### **DOCUMENTS REQUIRED (INTERNATIONAL STUDENTS)**

- 1** THREE (3) passport-sized photos
- 2** Copy of student's passport (at least 15 months validity)
- 3** Copy of parent's (father & mother) front-page passport detail & current valid pass or latest date of entry stamp
- 4** Original copy of parents' marriage certificate and the copy of the marriage certificate must be written/translated to English and certified by respective origin country or the embassy in Malaysia
- 5** Original copy of student's birth certificate and the copy of the birth certificate must be written / translated to English and certified by respective origin country or the embassy in Malaysia
- 6** Original copy of divorce certificate (if applicable) or a confirmation letter issued by the embassy in Malaysia if the certificate is not available. Copy of the birth certificate must be written/ translated to English and certified by respective origin country or the embassy in Malaysia
- 7** Original copy of foster child certificate and the copy of the certificate must be written/ translated to English and certified by respective origin country or the embassy in Malaysia
- 8** Original copy of death certificate of deceased parent (if applicable) or a confirmation letter & issued by the embassy in Malaysia if the certificate is not available. Copy of the death certificate must be written translated to English and certified by respective origin country or the embassy in Malaysia
- 9** Bank account statement. The bank statement must be written/translated to English and certified by respective origin country or the embassy in Malaysia.

### **Terms & Condition**

1. Boarding fees are invoiced 3 times per academic year and are payable before the commencement of school term.
2. The school reserves the right to impose a late payment charge of 5% per annum on all outstanding fees which have not been paid by the 15th day of the commencement of the new school term.
3. In the event of a withdrawal from the Boarding House, a one term's notice must be served. Failure to do so will result in the forfeiture of the deposit.
